



## The above table details the Program Year 2023 grants for the Land of Lincoln Workforce Alliance.

The <u>WIOA Formula grants</u> are the main grants allocated to our Local Workforce Innovation Area. The United States Department of Labor releases funding amounts around May or June of each year, which are then allocated by state governance to each Local Workforce Area based on population, local economies, unemployment rates, and employment trends. Formula grants run for two years on overlapping terms.

The QUEST (Quality Jobs, Equity, Strategy, and Training) Disaster Recovery Grant was to enable individuals who have been adversely affected by the COVID-19 pandemic and the social and economic inequities that the pandemic exacerbated, to enter, return to, or advance in high-quality jobs in growth industries including infrastructure, environment and climate, the care economy, and other locally identified critical sectors.

The <u>State Supplemental Grant</u> provided workforce training to manufacturers and their employees to assist with building their workforce and increase their retention rates.






## Illinois workNet® Center—Performance Outcomes: Adult




## Illinois workNet® Center—Performance Outcomes: Dislocated Worker

# Return on Investment: Title Exits Median Earnings PQTR 2 Adult 101 \$10,360.76 (3 months)

Median wages for adults completing WIOA training programs over a 12-month period were \$4,185,440. Allocated funding to the adult program for the year was \$1,017,689. The return on investment was 411%.

Median wages for dislocated workers completing WIOA training programs over a 12-month period were \$1,426,600. Allocated funding to the DW program for the year was \$634,115. The return on investment was 225%.
